Dear Mr. Kurzban:

Bob Barr, Michael J. Puglise and I represent Jean-Claude Duvalier, the Ex-President of Haiti.

Mr. Duvalier has recently returned to Haiti after a 25 year absence. He came back in order to help his fellow Haitians solve their myriad problems caused by both the earthquake and other factors.

As you know, there is approximately Six Million Dollars in the bank in Switzerland. These monies are involved in a Trust which was being used by his Mother, Simone Duvalier, before her death, to do various projects in Haiti.

These monies could be used today for the benefit of the Haitian people if they were released.

You were the attorney that represented Jean-Juste and others in the above styled lawsuit. Although there may be some questions as to whether Jean-Claude Duvalier was every actually served, you received a default judgment against him and his then wife, Michelle, in the sum of Five Hundred Four Million (\$504,000,000) Dollars.

That Judgment still stands in the United States today and although that money is not (and probably has never been) in existence; the Six Million Dollars is.

The Judgment provides that you receive Fifteen (15%) Percent of anything that you recover from the Defendants, plus all costs associated with the recovery of the funds.


As the only funds to which our Client has a claim is the monies in Switzerland, it is our belief that working together, we may be able to get those funds released which then could be used for Haiti (less the over Nine Hundred Thousand (\$900,000.00) Dollars that would go to you as your fees and costs.)

If you and your clients would agree that an independent, transparent and trusted entity, such as a world known accounting agency would handle the funds instead of the Haitian Commission which you suggested, and which was approved by the Court, we would get together with you and work out the details.

As time is of the essence, we would appreciate your reply as soon as practical.
